PREAMBLE :-

In the reference 1st cited, the Government Order in G.O.Ms.No.322 Health and Family Welfare (PME.2) Department dated 02.09.2020 has permitted the Managing Trustee, UIT Educational Trust, Coimbatore to start four years B.Sc Nursing Degree Course at "United College of Nursing", Gudalur Town Panchayat, Periyanaickenpalayam, Coimbatore District with an annual intake of 60 students from the academic year 2020-2021.

2. In the reference 2nd cited, the Managing Trustee, UIT Educational Trust, Coimbatore has requested the University to issue "Certificate of Registration" to start the B.Sc Nursing Degree Course at "United College of Nursing", Gudalur Town Panchayat, Periyanaickenpalayam, Coimbatore District with an annual intake of 60 seats for the academic year 2020-2021.

- 3. An Inspection was conducted on 24.09.2020 by the Inspection commission constituted for the said purpose and the commission has submitted the report. Scrutiny of the inspection report indicates the institution has fulfilled the necessary requirements for the issue of Certificate of Registration.
- 4. In the reference 3rd cited, the University has granted "Certificate of Registration" to UIT Educational Trust, Coimbatore for the establishment of a new institution in the name and style of "United College of Nursing", Gudalur Town Panchayat, Periyanaickenpalayam, Coimbatore District for the starting of B.Sc Nursing Degree Course.
- 5. In the reference 4th cited, the Managing Trustee, UIT Educational Trust, Coimbatore has requested the University to issue Provisional Affiliation to start the B.Sc Nursing Degree Course at "United College of Nursing", Gudalur Town Panchayat, Periyanaickenpalayam, Coimbatore District with an annual intake of 60 seats for the academic year 2020-2021.
- 6. In the referenc 5^h cited, the Tamil Nadu Nurses and Midwives Council, Chennai in their Letter No. Ref.No.60/NC/2020 dated 30.11.2020 had granted Provisional Recognition to the above said Institution to conduct 1st year Basic B.Sc(N) Programme for the academic year 2020-2021 only with an annual intake of not exceeding 60 seats.
- 7. An Inspection was conducted on 11.12.2020 by the Inspection commission constituted for the said purpose and the commission has submitted the report. Scrutiny of the inspection report indicates the institution has fulfilled the necessary requirements for the grant of Provisional Affiliation for the starting of the B.Sc Nursing Degree Course with an annual intake of 60 seats.

ORDER:-

Consequent to the issue of the Certificate of Registration, the University grants the Order of Provisional Affiliation to "United College of Nursing", Gudalur Town Panchayat, Periyanaickenpalayam, Coimbatore to start the B.Sc Nursing Degree Course with an annual intake of 60 (Sixty) seats for the academic year 2020 – 2021.

a. This order is granted subject to usual terms and conditions which are given in the Annexure.

The Provisional affiliation is granted subject to the following Condition.

i) The admission procedure as laid down in Government Order should be followed.

- ii) The Trust should obtain building plan approval from the Directorate of Town and Country Planning (DTCP) for the proposed Nursing College as mentioned in the Government Order No.G.O.(Ms.)No. 322/H&F.W(PME-2) Dept.dated.02.09.2020 (Sl.No.4(vi)).
- iii) The institution should obtain the periodical Indian Nursing Council approval year after year and forward the same to the University.
- iv) The candidates should be admitted before the cut off date and they will be registered to take up their I Year Examination as per existing regulations.
- v) There shall not be any admission after the cut off date.
- vi) The 2nd installment of Rs.2,50,000/- (Rupees Two Lakhs fifty thousand only) Security Deposit should be created for 2021 2022.
- vii) The Trust should undertake to abide by the provisions of the Tamil Nadu Dr.M.G.R. Medical University, Chennai, Act, 1987 (Tamil Nadu Act 37 of 1987) and by the Statutes, Ordinances, Regulations and Rules of the Tamil Nadu Dr.M.G.R. Medical University applicable to the Nursing Colleges framed from time to time.
- viii) The Trust should agree for the inspection of the college by the Tamil Nadu Dr.M.G.R. Medical University at any time according to the Statutes, Ordinances, Regulations and Rules for Nursing College framed from time to time.
- ix) The Trust should abide by the Statutes, Ordinances, regulations and Rules framed by the Tamil Nadu Dr.M.G.R. Medical University on matters of Syllabus, Examinations, Code of conduct, extracurricular activities, etc. according to the Statutes, Ordinances Regulations and Rules of the Tamil Nadu Dr. M.G.R. Medical University framed from time to time.
- x) The Conditions prescribed by the Indian Nursing Council, New Delhi and Tamil Nadu State Nursing Council, Chennai shall be followed. The Institution shall produce a copy of orders granting clearance/approval by Indian Nursing Council, New Delhi/Tamil Nadu Nursing Council, Chennai to this University for records.
- xi) Only qualified staff shall be appointed to handle the classes. No unqualified staff shall be appointed.
- xii) Only eligible candidates according to the regulations of this University shall be admitted to the 1st year B.Sc.(N) Degree Course. While making admissions, the Rule of Reservation of the Government of Tamil Nadu shall be adopted strictly.

- xiii) The sanctioned strength for the 1st year B.Sc.(N) Degree Course should be within the sanction intake. It should not be exceeded.
- xiv) There shall not be any financial commitment either to this University or to the Government.
- xv) Hostel accommodation shall be made available for the students.
- xvi) Required furniture shall be provided wherever they are necessary.
- xvii) Furnishing of false information to the University on any matter of suppression of facts while furnishing information to the University or violation of any of the Statutes, Ordinances, regulations, Rules, Instructions or conditions of affiliation shall result in withdrawal of the affiliation of the course.
- xviii)The institution shall show evidence of an annual income of not less than Rs.4,00,000/-(Rupees four lakhs only) excluding the interest accrued from the Security Deposit mentioned in the Statutes to facilitate the proper running of the proposed Nursing College.
- xix)The said trust should create the prescribed endowment with Director of Medical Education, Chennai vide G.O.Ms.No.1190, Health and Family Welfare Department, dated 30.8.1991.
- xx) The College shall furnish a "Utilization Certificate" to the University stating that the interest accrued on the Security Deposit created with this University shall be utilized towards maintenance of the Nursing College.
- xxi) The trust shall have a duly constituted Governing body with a representative of the teaching staff, to advise the Principal in the affairs of the College. A record of proceedings of the said Governing Body of the College shall be maintained by the Principal.
- xxii) The College shall furnish a Budget for each year of study and a separate development budget which will cover the expenses for the fulfillment of the requirements prescribed in the second, third and fourth year of the course of study.
- xxiii) The provisional affiliation now granted by the University is for the first year of B.Sc. Nursing degree course only.
- xxiv) After fulfilling all the conditions, required to be fulfilled by the College under the Tamil Nadu Dr.M.G.R. Medical University (Affiliation of Nursing Colleges) Statutes, by the end of the I year B.Sc. Nursing degree course of study, the institution shall apply to this University for the grant Continuance of provisional affiliation for the Second year B.Sc(N) degree course of study.
