ORDER:

The Tamil Nadu Nurses and Midwives Council resolves to grant **Conditional Continuance of Provisional Recognition (CPR)** to **United College of Nursing, Gudalur Town Panchayat, Periyanaickenpalayam, Coimbatore** to conduct the following programme for the academic years **2022-2023 & 2023-2024** subject to the following conditions:



1	B.Sc.,(N)	2022-2023 & 2023-2024	60

1. Do not admit underage & overage students.
2. Admission of candidates should not exceed the number indicated in Tamil Nadu Nurses and Midwives Council Order for the year 2022-2023 & 2023-2024 and admission must be made only once a year.
3. Every year list of candidates admitted during the year together with their age and qualification to be uploaded **in the Council's Institution Management System (I.M.S.)** for the purpose of registration. Also should come to the Council for certificate verification as and when informed by this Council.
4. The institution should not charge any capitation fee or donation for admission of candidates except the regular tuition and special fees as laid down in the prospectus/regulations.
5. **The institution should submit the copy of Affiliation Order from the TamilNadu Dr.M.G.R.Medical University for the academic years 2022-2023 & 2023-2024.**
6. **The institution has applied for CMDA/DTCP approval for College of Nursing and Hostel. Need to submit the CMDA/DTCP approval for College of Nursing and Hostel from competent authorities before the commencement of next academic year.**

7. **The institution should submit the copy of permission order for tie-up with Government Hospital, Mettupalayam and Periananickenpalayam, Rural Primary Health Centre, 4 Veerapandi & Urban PHC – Coimbatore Corporation for the academic year 2023-2024 along with the payment receipt details to this Council within three months.**
8. Failure to maintain the prescribed requirements will result in de- recognition.
9. The Council is entitled for surprise inspection without any prior notice. If the institution is found unsuitable, the recognition will stand cancelled and thereupon the Council shall not be responsible for the students admitted by the institution.
10. The institution shall have to abide by the guidelines/instructions/regulations issued by Tamil Nadu Nurses and Midwives Council, State Government/Indian Nursing Council, New Delhi from time to time.
11. The institution shall have to abide by the guidelines/instructions/regulations issued by Indian Nursing Council, New Delhi with regard to availability of Teaching faculty, Clinical and Physical Facilities, Infrastructural facilities in conformity with Regulations framed under the provisions of Indian Nursing Council Act 1947.
12. Annual Programme fee for B.Sc.,(N) must be paid by 30th June every year through online mode in Council website under the link “INSTITUTION MANAGEMENT SYSTEM”.
13. **Council Prescribed Uniform should be adoned by the students and it should be strictly adhered.**
14. All the correspondence should be done by the Principal only.
